

AN INTERSECTIONAL STUDY OF TRANSITIONING MENA YOUTH RESIDING IN MALTA

Youth transitions refer to the process that young people go through, from childhood to adulthood, and the changes that take place, including for example, leaving the family home, transitioning to employment and/or education, intimate relationships, marriage and becoming parents.

These transitions all occur within a particular temporal framework and spatial context. MENA (Middle East and Northern Africa) youth in transition residing in Malta might have to face other challenges related to elements of migration. The research will attempt to shed light on the intersectional diversity and potential inequalities that migrant MENA youth in transition encounter. The study will try to determine the main causes impacting the life courses and transitions of these youths as it is of paramount importance to keep in mind that not all migrant MENA youth in transition might possess a solid social identity required to overcome these intersectional mechanisms.

Why did the death of Lassana Cisse shock the nation?

The 6th of April 2024 commemorates the fifth anniversary from the brutal murder of Lassana Cisse. A tragic memory which is often portrayed as an isolated motiveless act from two individuals acting in their own personal capacity.

The murder of Lassana is not an isolated senseless act. It is a political crime driven by an institutionalised form of racism, shaped by a rhetorical discourse of racial hatred and an inhumane immigration policy that lets people drown at sea, whilst ruthlessly exploiting them for profit. The murder of Lassana is a clear example of how the rightist fascist dogma forms an integral feature of the neoliberal free market ideology which condones colonialism, cheap labour and slavery – an ideology that Malta is actively adopting in pursuit of economic growth. Justice for Lassana, as is the case for many other victims of racial hatred and political economic crimes, such as victims of the construction industry, remain unresolved. This unfortunately speaks a lot about the significance that Maltese society bestows to human rights and social justice.

Have we lost our humanity? Are we so alienated, trying to make sense of our unstable world, that we need to scapegoat others - through racial hatred, hateful social media comments, road rage, violence?

Climate change, a pandemic, financial, environmental, institutional and governance challenges – We are living in an unstable world, which leads to polarisation: us and them (Sacks, 2008).

Malta has been facing alarming manifestations of racism and xenophobia, notably through the proliferation of hate on social media towards migrants.

While it is crucial to acknowledge that not all Maltese harbor such sentiments, most of the Islands' society and their politicians have often displayed apathy and neglect. The tragic death of Lassana Cisse and the subsequent lack of accountability served as distressing confirmation of this disturbing reality. Structural violence and inhumane pushbacks further underline the systemic issues plaguing the country. Regrettably, the media's failure to address this problem adequately only perpetuates marginalization and moral panic, unfairly labeling refugees as folk devils. Integration has not been prioritized, leaving migrants vulnerable to exploitation and discrimination in the workplace and housing. Unfortunately, Malta learned nothing from the death of Lassana Cisse. A humane stance is needed to bring about change, demanding action from the government, media, and society as a whole to confront and dismantle these injustices and promote compassion and justice for all.
